Section 1 – Services Provided

The Provider agrees to perform babysitting services as requested by the Parent/Guardian for the child(ren) named above. Services shall be provided at the agreed-upon times and location, and in a safe, responsible, and professional manner.

Section 2 – Term and Termination

This Agreement shall remain in effect until terminated by either party upon written notice. Either party may terminate this Agreement at any time. Upon termination, any outstanding payments for services already rendered shall be due immediately.

Section 3 – Health and Safety

The Provider agrees to take all reasonable precautions to ensure the health and safety of the child(ren) during the provision of services, including adhering to any disclosed allergies, medical conditions, and emergency instructions provided by the Parent/Guardian.

Section 4 – Emergency Procedures

In the event of a medical emergency or other urgent situation, the Provider shall immediately notify the Parent/Guardian and seek appropriate medical treatment. The Parent/Guardian authorizes the Provider to consent to any emergency

medical treatment necessary for the child(ren).

Section 5 – Parental Instructions

The Parent/Guardian shall provide the Provider with all necessary information regarding the child(ren)'s routines, dietary restrictions, medications, and any other instructions relevant to the care of the child(ren). The Provider agrees to follow such instructions to the best of their ability.

Section 6 – Payment

The Parent/Guardian agrees to pay the Provider the compensation set forth above in accordance with the agreed payment schedule. Late payments may incur additional fees as determined by the Provider.

Section 7 – Confidentiality

Both parties agree to keep confidential any sensitive information obtained during the term of this Agreement, including but not limited to personal, medical, and financial information.

Section 8 – Liability

The Provider shall not be liable for any indirect, incidental, or consequential damages arising from the provision of babysitting services. The Parent/Guardian holds the Provider harmless from any claims or damages except those resulting from gross negligence or willful misconduct.

Section 9 – Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the State of _____. Any disputes arising under this Agreement shall be resolved in the appropriate courts located within _____ County, _____.

Section 10 – Entire Agreement

This Agreement constitutes the entire understanding between the parties and supersedes all prior agreements, oral or written, concerning the subject matter herein. No modification or waiver of any provision shall be effective unless in writing and signed by both parties.

Section 11 – Severability

If any provision of this Agreement is held to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

Section 12 – Independent Contractor

The Provider is an independent contractor and not an employee of the Parent/Guardian. Nothing in this Agreement shall be construed to create a partnership, joint venture, or employer-employee relationship.

Section 13 – Background Check and References

The Provider affirms that they have provided truthful information regarding their qualifications and background. The Parent/Guardian may request references and background checks prior to engagement.

Section 14 – No Waiver

Failure by either party to enforce any provision of this Agreement shall not be deemed a waiver of future enforcement of that or any other provision.

Section 15 – Amendments

Any amendments or supplements to this Agreement must be in writing and signed by both parties to be effective.

Section 16 – Signatures

This Agreement may be executed in counterparts and delivered electronically or in hard copy, each of which shall be deemed an original.
