

# BEHAVIOR CONTRACT AGREEMENT

## PURPOSE:

This Behavior Contract Agreement (“Agreement”) is made between the above-named Student, Parent(s)/Guardian(s), and School to establish clear expectations for conduct and responsibilities to promote a positive educational environment. This Agreement is legally binding and enforceable under applicable United States law.

## TERMS AND CONDITIONS:

### 1. Expected Behavior:

The Student agrees to adhere to the school’s code of conduct, respect school property, staff, students, and participate positively in all school activities. Any form of bullying, harassment, violence, or disruption is strictly prohibited.

### 2. Responsibilities of the Student:

The Student shall attend all classes punctually, complete assignments honestly and on time, follow instructions, and seek help when needed. The Student agrees to comply with all school policies and procedures as outlined in the student handbook.

### 3. Responsibilities of the Parent(s)/Guardian(s):

Parent(s)/Guardian(s) agree to support the Student’s academic and behavioral progress by maintaining open communication with school personnel, supervising homework, attending conferences as required, and reinforcing the importance of school rules and expectations.

### 4. Consequences of Non-Compliance:

Should the Student fail to comply with the terms of this Agreement, consequences may include, but are not limited to, verbal warnings, detention, suspension, or other disciplinary actions consistent with school policy. The school reserves the right to take appropriate legal action if necessary.

### 5. Duration and Review:

This Agreement shall remain in effect for the current academic year or until the behavior concerns are resolved satisfactorily. The Agreement may be reviewed and amended upon mutual consent of the parties in writing.

### 6. Confidentiality:

All parties agree to keep the terms of this Agreement confidential except when disclosure is required by law or school policy.

### 7. Legal Compliance:

This Agreement is governed by the laws of the United States and the specific state in which the school is located. Any disputes arising under this Agreement shall be resolved in accordance with applicable law, including due process rights afforded to students.

**8. Additional Support and Services:**

The school may provide or recommend additional support services such as counseling, academic assistance, or behavioral interventions to aid the Student in fulfilling the terms of this Agreement.

**9. Waiver:**
