Each Party represents that they have the legal capacity to enter into this Agreement and that they are not under duress, undue influence, or coercion.

**8. Representation by Counsel**

Each Party acknowledges they have had the opportunity to consult with independent legal counsel regarding this Agreement.

**9. Effective Date**

This Agreement shall become effective upon execution by both Parties.

**10. Dispute Resolution**

Any disputes arising under this Agreement shall be resolved through mediation prior to any court proceedings.
