Adoption Terms and Conditions:

1. Adoption Fee

The Adopter agrees to pay an adoption fee which covers the cost of veterinary care, vaccinations, spay/neuter, and other related expenses. Payment must be made to the Shelter prior to or at the time of adoption.

2. Health and Vaccinations

The Shelter represents that the Dog has received appropriate vaccinations and medical care to date. The Dog is adopted AS-IS and the Shelter makes no further warranties except those detailed in this Agreement.

3. Care and Maintenance

The Adopter agrees to provide proper food, water, shelter, medical care, and humane treatment at all times during the Dog's lifetime.

4. Spay/Neuter

If not already altered, the Adopter agrees to have the Dog spayed or neutered within a reasonable timeframe as recommended by a licensed veterinarian.

5. Return Policy

If the Adopter cannot keep the Dog for any reason, the Dog must be returned to the Shelter. The Dog may not be sold, transferred, or given to another party without prior written consent from the Shelter.

6. Inspection Rights

The Shelter reserves the right to request and/or perform a home visit or other check-ins to ensure the Dog's wellbeing and proper care.

7. Transfer of Ownership

Ownership of the Dog transfers to the Adopter upon execution of this Agreement and receipt of the adoption fee.

8. Liability

The Adopter agrees to hold harmless and indemnify the Shelter and its representatives from any liabilities, claims, or damages arising from the care, behavior, or actions of the Dog after adoption.

9. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the State of _____ without regard to conflict-of-law principles.

10. Entire Agreement

This document constitutes the entire Agreement between the parties and supersedes all prior negotiations and understandings. Any amendments must be in writing and signed by both parties.

11. Severability

If any provision of this Agreement is deemed invalid, illegal, or unenforceable, the remaining provisions shall remain in full force and effect.

12. Signatures; Counterparts

This Agreement may be executed in counterparts, each of which shall be deemed an original, and all of which together shall constitute one and the same instrument.
