I, the undersigned, being of sound mind and legal age, hereby declare this to be my Last Will and Testament, revoking all prior wills and

ARTICLE I – DECLARATION

ARTICLE VII – NO CONTEST CLAUSE

If any beneficiary under this Will contests this Will or any of its provisions, any share or interest in my estate given to that person is hereby revoked and shall be disposed of as if that person had predeceased me without issue.

ARTICLE VIII – OMISSION

I acknowledge the existence of my children and/or heirs named herein. Should I have omitted to provide for any child or heir, such omission is intentional.

ARTICLE IX – GOVERNING LAW

This Will shall be governed by and construed in accordance with the laws of the State of _____, United States of America.
