

LAST WILL AND TESTAMENT

Article 6 – Guardianship

If I am the parent or legal guardian of minor children at the time of my death, I appoint _____ to serve as guardian of the person and estate of such minor children. If this person is unable or unwilling to serve, I appoint _____ as alternate guardian.

Article 7 – Powers of Executor

My Executor shall have all powers allowed under the laws of the State of Oklahoma, including but not limited to the power to sell, lease, mortgage, or otherwise dispose of any real or personal property without court approval, to settle claims for or against the estate, and to make distributions in cash or in kind.

Article 8 – No Contest Clause

If any beneficiary under this Will, or any person claiming under them, directly or indirectly contests this Will or any of its provisions, any share or interest in my estate given to that contesting beneficiary or person is revoked and shall pass as if that contesting beneficiary had predeceased me without issue.

Article 9 – Governing Law

This Will shall be governed by and construed in accordance with the laws of the State of Oklahoma, without regard to conflict of law principles.
