Parents shall communicate respectfully and directly regarding matters affecting the child and shall keep each other informed of the child's welfare, education, and health.

## Relocation:

Either parent intending to relocate with the child shall provide notice to the other parent as required by Arizona law, and both parties shall comply with relocation procedures mandated by the court.

**Dispute Resolution:**

Parents agree to make good faith efforts to resolve disputes related to this Parenting Plan through mediation or other alternative dispute resolution methods before seeking court intervention.

**Modification:**

This Parenting Plan may be modified only upon mutual written agreement of the parents or by court order in accordance with Arizona law.

**Acknowledgments:**

Both parents acknowledge that this Parenting Plan is made voluntarily and is intended to be legally binding and enforceable under the laws of the State of Arizona.
