Custody Arrangement:

The parents agree to a custody arrangement that serves the best interests of the child(ren) as follows:

- Legal Custody: Joint legal custody, with both parents sharing decision-making responsibilities regarding health, education, and welfare.

Education:

Both parents shall have the right to participate in educational decisions and receive school records and information.

- Both parents shall be notified of all school events and meetings.
- Parents shall consult each other on major educational decisions.

Child Support:

Child support shall be paid according to Ohio law and any existing court order or agreement.

In the event of disputes arising under this Parenting Plan, the parents agree first to attempt resolution through mediation before seeking court intervention.

Modification:

This Parenting Plan may be modified only by a written agreement signed by both parents or by court order.

Legal Compliance:

This Parenting Plan is intended to be legally enforceable under the laws of the State of Ohio and shall be incorporated into any custody orders issued by the court.
