## Communication and Access:

Both parents shall encourage frequent and meaningful contact between the child(ren) and the other parent. Electronic communication (phone calls, video chats, emails, texts) shall be permitted during reasonable hours and without interference.

Neither parent shall unreasonably withhold consent for communication.

**Child Support:**

Child support shall be paid in accordance with Oregon child support guidelines. Payments shall be made by Parent 1 / Parent 2 (circle one) in the amount of \$\_\_\_\_\_ per month to the other parent. The paying parent shall provide proof of payment and maintain records.

**Health Care and Insurance:**

The parents agree to maintain health insurance coverage for the child(ren) and share reasonable uninsured medical expenses, including dental and vision care, according to their respective financial abilities.

Each parent shall promptly inform the other of any health care emergencies or significant medical issues.

**Education:**

The parents shall confer and make joint decisions regarding the child(ren)'s education, including school choice, enrollment, extracurricular activities, and special education services.

Both parents shall receive school reports and be invited to parent-teacher conferences.

**Relocation:**

Neither parent shall relocate the child(ren) out of the area without providing at least 60 days written notice to the other parent.

If relocation is proposed, the parents shall negotiate a revised parenting plan or seek court intervention if agreement cannot be reached.

**Dispute Resolution:**

The parents agree to attempt mediation or alternative dispute resolution before seeking court intervention for any disputes arising under this parenting plan.

**Modification:**

This parenting plan may be modified by mutual written agreement of the parties or by court order upon a showing of a substantial change in circumstances affecting the child's welfare.
