Custody Terms:

1. Custodial Owner grants temporary custody of the Pet to the Caretaker under the terms set forth herein.
2. Caretaker agrees to provide care, food, water, shelter, medical attention, and affection to the Pet as a reasonable and prudent pet owner.
3. The Parties agree that Custodial Owner retains ultimate ownership of the Pet at all times.
4. Caretaker shall not transfer ownership, sell, or permanently relinquish the Pet without prior written consent of Custodial Owner.
5. Caretaker agrees to keep the Pet safe and secure and to notify Custodial Owner promptly of any health issues or emergencies.

Medical and Emergency Care:

Caretaker is authorized to seek emergency veterinary care if Custodial Owner cannot be reached promptly, and agrees to inform Custodial Owner as soon as possible.

Custodial Owner agrees to reimburse Caretaker for reasonable emergency veterinary expenses incurred on behalf of the Pet upon presentation of receipts.

Duration and Termination:

This Agreement shall commence upon execution and remain in effect until terminated by either Party with written notice.

Upon termination, Caretaker shall return the Pet to Custodial Owner in good health and condition, ordinary wear and tear excepted.

Liability and Indemnification:

Caretaker assumes all responsibility and liability for the Pet's care during custody and agrees to indemnify and hold harmless Custodial Owner from and against all claims, damages, and expenses, including reasonable attorneys' fees, that may be asserted against or incurred by Custodial Owner in connection with the Pet's custody.

Custodial Owner shall not be liable for any injury, illness, or damage caused by the Pet while in Caretaker's custody.

Governing Law and Jurisdiction:

This Agreement shall be governed by and construed in accordance with the laws of the United States and the specific state agreed upon by the Parties.

Entire Agreement:

This Agreement constitutes the entire understanding between the Parties and supersedes all previous agreements, understandings, and negotiations, whether written or oral.
