Trust Property and Funding:

The Grantor hereby transfers and delivers to the Trustee the property described below, to be held in trust for the benefit of the Pet Beneficiary.

Trustee Powers and Duties:

The Trustee shall hold, manage, invest, and reinvest the trust property, collect income therefrom, and distribute trust funds for the health, maintenance, support, and welfare of the Pet Beneficiary. The Trustee shall use reasonable discretion in administering the trust, including hiring veterinarians, caretakers, and other services as necessary to provide for the Pet's care. The Trustee shall keep accurate records and provide reports to the Grantor or other named persons as required.

Duration and Termination:

This trust shall continue for the lifetime of the Pet Beneficiary. Upon the death or permanent incapacity of the Pet, the remaining trust property shall be distributed according to the instructions set forth below or otherwise as provided by law.

Disposal of Remaining Trust Property:

Upon the death or permanent incapacity of the Pet Beneficiary, the Trustee shall distribute any remaining trust property as follows:

- To the following individual(s) or entity(ies): _____

- If none, to the Grantor or the Grantor's estate.
- If no such person or entity exists, to a recognized animal welfare organization at the Trustee's discretion.

5. Counterparts and Electronic Signatures: This Agreement may be executed in counterparts, including electronically.
