

SEPARATION AGREEMENT TEMPLATE IRELAND

Background:

This Separation Agreement (the “Agreement”) is made between the parties named above (the “Parties”). The Parties were formerly in a marital relationship but have decided to separate. The Parties wish to record their mutual agreement on the terms of their separation, including arrangements relating to finances, property, maintenance, and any other relevant matters.

1. Definitions

In this Agreement, unless the context requires otherwise, the following terms shall have the meanings ascribed to them: “Agreement” means this Separation Agreement; “Parties” means the individuals named above; “Property” means any assets, real or personal, owned by either Party.

2. Separation

The Parties agree that they have separated and will live separate and apart from each other from the date they both sign this Agreement. Each Party shall be free from interference, harassment, authority, and control by the other, direct or indirect.

3. Custody and Access

If the Parties have children together, the arrangements for custody and access shall be as follows: The Parties agree to share custody in a manner that promotes the welfare of the children and complies with the best interests standard under applicable law. Specific arrangements, visitation schedules, and decision-making responsibilities shall be mutually agreed or as set out in attached Schedule A.

4. Maintenance and Support

The Parties agree to the following terms regarding maintenance and support: Each Party shall be responsible for their own financial needs unless otherwise set out herein or required by law. Maintenance payments, if any, shall be made in accordance with the attached Schedule B or as otherwise mutually agreed in writing.

5. Property Division

The Parties agree to divide their property as follows: Each Party shall retain ownership of personal property currently in their possession unless otherwise agreed. Real property, financial accounts, and other assets shall be divided as set forth in attached Schedule C. The Parties acknowledge that this division is fair and reasonable and intended to be final and binding.

6. Debts and Liabilities

Each Party shall be responsible for their individual debts incurred after separation. Joint debts and liabilities shall be

settled or allocated as set out in attached Schedule D. The Parties agree to cooperate in the discharge or transfer of any joint obligations.

7. Release

Except as otherwise provided in this Agreement, each Party releases and discharges the other from any further claims, demands, or liabilities arising out of the marital relationship or its ending, including claims for support, property, or other financial relief.

8. Legal Advice and Independent Counsel

Each Party acknowledges that they have had the opportunity to seek independent legal advice before signing this Agreement and that they fully understand its terms and legal consequences.

9. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the United States of America. Any disputes arising from or relating to this Agreement shall be subject to the exclusive jurisdiction of the courts of the United States.

10. Entire Agreement

This Agreement contains the entire understanding between the Parties relating to the subject matter hereof and supersedes all prior agreements, understandings, and negotiations, whether oral or written.

11. Amendments

No amendment or modification to this Agreement shall be valid unless it is in writing and signed by both Parties.

12. Severability

If any provision of this Agreement is found to be invalid or unenforceable, the remainder of this Agreement shall remain in full force and effect.

13. Execution in Counterparts

This Agreement may be executed in counterparts, each of which shall be deemed an original but all of which together constitute one and the same instrument.
