Section 1 – Agreement to Provide Wedding Cake

The Baker agrees to prepare and deliver a wedding cake as described herein to the Client in accordance with the specifications and terms set forth in this Agreement.

Section 2 – Customization and Design

The Client agrees that all details regarding cake flavor, fillings, frosting, decorations, and theme have been discussed and agreed upon. Any changes after signing this Agreement may incur additional charges and require additional time.

Section 3 – Deposit and Payment

A non-refundable deposit as specified above is required to secure the date and initiate preparation. The remaining balance is due by the date stated in this Agreement. Failure to pay the balance on time may result in cancellation of services.

Section 4 – Delivery and Setup

The Baker will deliver and, if agreed, set up the wedding cake at the specified location and time. The Client is responsible for providing safe and accessible delivery and setup conditions. Any delays or issues caused by the Client may affect the Baker's liability.

Section 5 – Allergies and Dietary Restrictions

The Client represents that all dietary restrictions, allergies, and special requirements have been disclosed to the Baker prior to execution of this Agreement. The Baker is not responsible for adverse reactions if information is withheld or inaccurate.

Section 6 – Cancellation and Refund Policy

Cancellation of the order must be made in writing. The deposit is non-refundable. If cancellation occurs within a timeframe that requires cancellation of supplies or labor, additional fees may apply.

Section 7 – Liability

The Baker shall not be liable for any damages, losses, or injuries arising from the use or consumption of the wedding cake except as caused by gross negligence or willful misconduct of the Baker.

Section 8 – Food Safety and Compliance

The Baker warrants that the wedding cake will be prepared in compliance with all applicable health and safety regulations. The Client acknowledges responsibility for proper storage and handling after delivery.

Section 9 – Photography and Publicity

The Baker reserves the right to use photographs of the wedding cake for promotional purposes unless the Client provides written notice to the contrary.

Section 10 – Governing Law and Venue

This Agreement shall be governed by and construed in accordance with the laws of the United States and the specific state of performance. Any disputes arising hereunder shall be subject to the exclusive jurisdiction of the courts located in the applicable state.

Section 11 – Entire Agreement

This Agreement constitutes the entire understanding between the parties with respect to the subject matter herein and supersedes all prior negotiations or agreements, oral or written.

Section 12 – Amendments

Any amendments or modifications to this Agreement must be in writing and signed by both parties.

Section 13 – Severability

If any provision of this Agreement is held invalid or unenforceable, the remainder shall continue in full force and effect.

Section 14 – Signatures

The Client and Baker agree to the terms and conditions of this Agreement and indicate so by their signatures below.
