Cancellation and Refund Policy:

Client may cancel this Agreement by providing written notice to Photographer. Deposits are non-refundable except as otherwise specified herein. If cancellation occurs prior to the event date, the Client remains responsible for any outstanding balance. In the event of Photographer's inability to perform due to unforeseen circumstances, all payments received will be refunded in full.

Intellectual Property Rights:

All photographs, negatives, digital files, and related materials remain the sole property of the Photographer. Photographer grants Client a limited, non-exclusive license to use the photographs for personal, non-commercial

purposes. Client shall not sell, publish, or use images for commercial purposes without Photographer's prior written consent.

Liability and Indemnification:

Photographer is not responsible for any injury, damage, or loss incurred during the event. Client agrees to indemnify, defend, and hold harmless Photographer against any claims arising from Client's actions or from the event.

Photographer's liability for any claim arising under this Agreement shall be limited to the total amount paid by Client to Photographer.

Force Majeure:

Neither party shall be liable for failure or delay in performance due to causes beyond reasonable control, including but not limited to acts of God, war, terrorism, government restrictions, natural disasters, or pandemics. In such event, parties shall make best efforts to reschedule or otherwise resolve the matter in good faith.

Governing Law and Venue:

This Agreement shall be governed by and construed in accordance with the laws of the State of _____, without regard to its conflict of law principles. The parties consent to the exclusive jurisdiction and venue of the state and federal courts located in _____ County, _____.

Entire Agreement and Amendments:

This document constitutes the entire agreement between the parties regarding the subject matter herein and supersedes all prior agreements or understandings, whether written or oral. Any amendments or modifications must be in writing and signed by both parties.

Severability:

If any provision of this Agreement is found to be invalid or unenforceable, the remainder of this Agreement shall remain in full force and effect, and such provision shall be replaced by a valid provision that most closely reflects the original intent.

Dispute Resolution:

Any dispute arising out of or relating to this Agreement shall first be attempted to resolve through good faith negotiation between the parties. If unresolved, disputes shall be submitted to mediation before a mutually agreed upon mediator. If mediation fails, parties may pursue any legal remedies available under applicable law.
